This office intends to establish a Gym for the fitness of police personnel at PS Saket, South District, New Delhi. Thus, in order to begin with the project, initially there is requirement of branded (i) Multistation Gym (ii) Motorized Trade Mill and (iii) Cardio Air Bike as per specifications mentioned in **Annexure-A** :-

The firms dealing with the supply of branded Gym Equipments may submit their rates within stipulated time period. The word **"QUOTATION FOR SUPPLY OF GYM EQUIPMENTS REQUIRED FOR INSTALLATION AT PS SAKET, SOUTH DISTRICT"** shall be prominently marked on the top of envelope

The sealed tender should reach in this office up to 12.00 noon on or before 26/12/2017 by Regd. Post/Courier/by hand. The bidder may also submit their quotations personally in the sealed Tender Box available in Admn. Branch, Room No.311, 3rd Floor, Office of DCP/South District, Hauz Khas, New Delhi. The tender will be opened by Tendering Committee on 29/XII/17 at 03.00 PM in the presence of representative of interested firms.

Terms & Conditions.

1. GST Registration with Sales Tax/Service Tax Department: The bidders should have GST registration with the Sales Tax/Service Tax Department and shall furnish scanned copies of the GST registration with their Bid alongwith their latest Tax deposit challan/return.
2. The tendering firm should submit a separate certificate confirming that it shall supply all the articles/equipments as per specification mentioned in this Tender (Annexure-A) once declared successful bidder after finalization of Tender. In case the successful bidder fails to supply the articles as per approved specification (Annexure-A) or there is any variation in the specification of equipments for any reason, it shall be considered as misleading and wastage of time and further liable for proceedings of Black Listing.


3. The Tendering Committee , South District if feels necessary, may ask any bidding firm for demonstration/ inspection of equipments and to ascertain its specification. The final decision regarding specification, quality, rate and finalization of Tender lies solely in the hand of Tendering Committee, South District. The decision of Tendering Committee, South District will be final and no plea for any bidder will be entertained.
4. A copy of the tender documents terms & conditions as well as specification of equipments (Annexure-A) duly signed by the bidder(s) may also be attached with the tender quotation. Unsigned tender documents shall not be accepted at any cost.
5. All the firms participating in the Tender must submit a Certificate to the effect that the firm is neither blacklisted by any Govt. Department nor any Criminal Case is registered against the firm or its owner or partners anywhere in India.
6. Tenderers must quote the net price in figures as per the proforma given at **Annexure -B**. Any over writing/cutting etc. render the tender invalid.
7. Percentage (%) of TAX, if any to be claimed shall be indicated clearly in the quotation.
8. The tenderers shall also mention this office reference number in the quotation.
9. No correction fluid/cutting, over writing shall be allowed and such tender shall be rejected straightway.
10. No advance payment shall be given to any agency on any ground what so ever.
11. Conditional tender shall not be accepted at any cost and will be rejected straightway.
12. The purchase committee reserves the right to relax any of the above mentioned conditions and reject on his discretion any or all tender(s) altogether without assigning any reason.
13. All disputes in this connection shall be settled in Delhi Jurisdiction only. Prior to litigation, the matter can be patched up by negotiation on table.
14. All the firms participating in the Tender must submit a Certificate to the effect that the firm is neither blacklisted by any Govt. Department

nor any Criminal Case is registered against the firm or its owner or partners anywhere in India.

15. Details of rates of each equipment should to be quoted as per proforma given vide Annexure-B, in words. No cutting and overwriting will be considered and the bid shall be rejected. The option in rate will not be entertained.
16. ***The final decision to declare successful bidder shall be made by Tendering Committee, South District on fulfilling that bidder is competent to supply good quality branded equipments as per approved specifications and over all Lowest Rate expressed by the bidder in Grand Total of all the items mentioned in Price Performa i.e. Annexure-B.***
17. **Guarantee/Warranty :**
 - (a) The Supplier shall provide comprehensive on-site Guarantee/Warranty for above said Gym Equipments as per mentioned in Annexure-A. The commencement of guarantee/warranty period shall be counted from the date it is completely installed and given satisfactory report from the end user. Obtaining satisfactory report from the end user shall be the responsibility of supplier.
 - (b) The Supplier must have a maintenance base in Delhi to provide maintenance service to the Gym Equipments System efficiently and promptly.
 - (c) If the performance of any individual equipment or System fails to meet the contract specifications then the same shall be replaced by the Supplier free of cost during the term of the warranty/guarantee period.
 - (d) The maintenance services including spares shall be provided free of cost during the warranty/guarantee period. No extra charges shall be paid on the pretext of maintenance or change of spare parts.
 - (e) During the term of warranty/guarantee the service/repair calls will have to be attended by the Supplier within four hours between 9.30 A.M. to 6.00 P.M. on working day from Monday to Saturday from the time of such calls.
 - (f) The defective item/equipment should be repaired the same day at Purchaser's location. In case of major defects requiring the defective item/equipment is required to be taken to the Supplier's workshop, it should be returned within one week duly repaired and an immediate substitute item/equipment will be provided by the Supplier for the

smooth operation of the System. The to and fro transportation of the card/item/equipment will be the responsibility of Supplier.

- (g) The interested bidder before quoting their price should note that no extra charges shall be paid for transportation and installation of Gym Equipments.
